- 5. Coordinate the implementation of the Association's strategic plan and realization of its objectives
- 6. Ensure prudent management of resources and assets of the Association.
- 7. Oversee the development and implementation of effective management and administrative policies, systems and subcommittees.
- 8. Maintain strong working partnership with the National Executive Officer and staff of the Association.
- 9. Supervise, advise and support all Commissioners, to ensure that their needs are met and that they deliver quality Girl Guiding.
- 10. Be the official representative of the Association.
- 11. Chair the meetings of the Technical Advisory Committee of the Association.
- 12. Ensure proper management and accountability of funds in line with the Association's financial and budgetary policies and procedures, xiii. identify and source for strategic development partners; and xiv. ensure that annual financial audit is conducted, and recommendations addressed.
- 13. Be an ex-officio member of all Council committees.
